

Dependency Map Add-On End User Licence Agreement

1. Introduction

Unless otherwise indicated, the add-on is the property of FindOut Technologies AB. The software and services provided by FindOut Technologies AB are at all times subject to these terms and conditions. By using the add-on you confirm your acceptance of, and agree to be bound by, these term and conditions. These terms and conditions shall constitute the agreement between you and FindOut Technologies AB ("this Agreement").

2. Agreement to Terms and Conditions

This Agreement takes effect on the date on which you install the add-on into any Jira installation.

3. License Duration

This license is perpetual, no additional payment is required to maintain it, with the exception of you breaking any part of this license, in which case you lose all rights under the license.

4. Disclaimer

It is not warranted that any software supplied by FindOut Technologies AB will meet your requirements or that its operation will be uninterrupted or error free. FindOut Technologies AB exclude and expressly disclaim all express and implied warranties or conditions not stated in this Agreement (including without limitation, loss of profits, loss or corruption of data, business interruption or loss of contracts), so far as such exclusion or disclaimer is permitted under the applicable law. This Agreement does not affect your statutory rights.

5. Warranties and Limitation of Liability

FindOut Technologies AB warrants that its software and services will be provided using reasonable care and skill on a non-exclusive basis. Where FindOut Technologies AB supplies any goods supplied by a third party, FindOut Technologies AB does not give any warranty, guarantee or other term as to their quality, fitness for purpose or otherwise.

Except in respect of death or personal injury caused by FindOut Technologies AB's negligence, FindOut Technologies AB shall not be liable to you by reason of any representation (unless fraudulent), or any implied warranty, condition or other term, or any duty at common law, for any loss of profit or any indirect, special or consequential loss, damage, costs, expenses or other claims (whether caused by FindOut Technologies AB's negligence or the negligence of its servants or agents or otherwise) which arise out of or in connection with the provision of any goods or services by FindOut Technologies AB.

You shall not assign this Agreement or any benefits or interests arising under this Agreement without FindOut Technologies AB's prior written permission.

8. Ownership

The ownership of marketing materials, any software or electronic media, methodologies, strategies, research and designs shall remain with FindOut Technologies AB. FindOut Technologies AB reserves the right to use in any way it wishes any programming tools, skills, content, methodologies, strategies and techniques acquired or used in performing its duties under this Agreement. The ownership of any data content created using the software shall remain with the author of that content. You may use data content created using the software for any purpose that does not interfere with the business operations of FindOut Technologies AB.

9. General Terms and Law

This Agreement is governed by the laws of Sweden. You acknowledge that no joint venture, partnership, employment, or agency relationship exists between you and FindOut Technologies AB as a result of your use of these services. You agree not to hold yourself out as a representative, agent or employee of FindOut Technologies

AB. You agree that FindOut Technologies AB will not be liable by reason of any representation, act or omission to act by you. FindOut Technologies AB's performance under this Agreement is subject at all times to existing laws and legal process and nothing contained in this Agreement is in derogation of FindOut Technologies AB's right to comply with law enforcement requests or requirements relating to your use of FindOut Technologies AB or information provided to or gathered by FindOut Technologies AB with respect to such use.

10. Severability

If any of the provisions of this Agreement is judged to be illegal or unenforceable, the remainder shall remain in full force and the effect of the remainder will not be deemed to be prejudiced (unless the substantive purpose of this Agreement is then frustrated, in which case either party may terminate this Agreement forthwith on written notice).
